OVERVIEW

CORPORATE SECRETARIAL SERVICES

We can provide local directors and company secretarial services, including provision of a registered office and nominee shareholders, and would arrange Board Meetings and Annual General Meetings. We would also prepare and file the returns required under Guernsey company law.

ADMINISTRATION SERVICES

We would provide administration services as necessary, which would depend upon the business of the company.

ACCOUNTING SERVICES

We would maintain accounting books and records and can prepare quarterly management information and reports as required. Following the year end, we would prepare full annual accounts in an agreed format, and would arrange for their audit if required.
