#### CONCEPT

A Retirement Annuity Trust Scheme ("RATS") is a form of personal pension arrangement solely for Guernsey residents. It is established under trust and is permitted to have fairly wide investment options subject to certain restrictions imposed by the States of Guernsey Income Tax Department.

RATS may be established on an individual basis or individuals may join a Group arrangement. Our Group RATS is the Blue Riband Guernsey Retirement Annuity Trust Scheme and further details may be found at www.blueribandplan.com.

#### CONSULTANCY SERVICES

Prior to the establishment of a RATS, we can discuss the full range of alternative pension options with the client to ensure that a RATS is the most appropriate pension arrangement in the circumstances.
